

Rental Agreement

- No more than five (5) children are to use the bounce house simultaneously.
- Bounce house must be placed and fully inflated on a flat, level surface free of sticks, debris, or other sharp objects.
- There **MUST** be an adult watching bounce house when children are playing **AT ALL TIMES!**
- Anyone with head, neck, or back injuries, pregnant women, and children under the age of 2 are not permitted in the inflatable at any time.
- Do not bounce against the sides or near the doorway of the bounce house - serious injury may result.
- No shoes are to be worn while on the equipment
- No food, drink, or other sticky substances allowed on the inflatable
- No smoking on or near the inflatable.
- Sharp objects must be removed from pockets before participating in the use of the bounce house.
- The bounce house must be staked down using the provided stakes, at all designated locations.
- The bounce house is **NOT** to be inflated or used if wind gusts exceed 10 mph, or if lightning is present in the area.
- If the inflatable begins to lose air, exit the bounce house immediately.
- Do not operate the bounce house when it is raining. Risk of serious injury due to slipping hazards and electric shock from the blower if wet conditions exist.
- Electrical chords providing power to the bounce house must be free and clear of any paths that persons may cross.
- If there is damage to the equipment as a result of failure to adhere to these rules, the renter agrees to pay additional fees, up to \$2,000.00 if the equipment is beyond repair.

Weather Policy

We reserve the right to cancel any reservations due to severe or imminent deterioration of weather conditions.

Cancellation Policy

A 7-day notification of cancellation is required (except due to weather conditions).

Waiver and Release From Liability

WARNING:

BOUNCING ON A BOUNCE HOUSE MAY RESULT IN SERIOUS INJURY AND/OR DEATH

On behalf of all children and adults in my care participating in activities at involving the inflatable bounce houses, I acknowledge and agree to the terms and conditions of this waiver as identified below:

I _____, have voluntarily elected to allow my child(ren) and individuals in my care to participate in playing on bounce house(s), and I fully understand that this involves jumping on air-filled entertainment toy(s) and that there are health and safety risks associated with this type of activity. I, therefore, assume all risk of injury and/or death associated with this event and I will not hold the bounce house owners, event organizers, sponsor, or anyone affiliated with them for any circumstances of the event.

Should any individuals be dropped off in my care for use of the inflatable bounce house, I will inform them to follow all rules of participation.

I hereby waive and release, indemnify, hold harmless and forever discharge you, the owners of this bounce house.

I understand that the activities that they will participate in on the date the bounce house(s) is/are used are inherently dangerous and participation may cause harm or grievous injuries, including bodily injury, damage to personal property and/or death. I, on help of myself, my spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and death sustained to me or my property that I may have against the aforementioned Released Parties to such activity.

By this WAIVER AND RELEASE, I assume any risk, and take full responsibility and warranty of any and all claims of personal injury and death or damages to, but not limited to my use of the Released Parties' facilities and/or engaging in the Release Parties' activities or other activities on and near the Release Parties' premises on the date the house(s) are used.

This WAIVER AND RELEASE contains the full and complete agreement between the Parties, the items are contractual and not merely a recital, and supersedes any and all prior written or oral agreements and representations between the parties concerning the activities and the WAIVER AND RELEASE. Any additional changes in this WAIVER AND RELEASE shall be valid only if set forth in writing and signed by all parties. Furthermore, this WAIVER AND RELEASE is binding upon the undersigned and his/her respective spouse, heirs, next of kin, executors, administrators, representatives, successors and assigned.

This WAIVER AND RELEASE shall be subject to the laws of the State of Iowa. The provisions of this WAIVER AND RELEASE will remain in issue and in full force and effect even after termination of the Parties' activities.

I acknowledge that I have read, understand, and fully agree to the terms of this WAIVER AND RELEASE and its contents. I have signed this WAIVER AND RELEASE voluntarily, under no duress or threat of duress, without inducement, promise, or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional WAIVER AND RELEASE of all liability to the full extent of the law. I am 18 years of age or older and mentally competent to enter into this waiver.
